Guarantees and other memorand um accounts

These notes have been prepared in accordance with the provisions of the Civil Code Article 2424, last paragraph, and Civil Code Article 2427 no. 9.

Company assets held by third parties are refrigerators on loan to important customers.

The guarantee account "guarantees from holding company" amounting to 3,895 million lire represents guarantees issued by the holding company, **Finanziaria Centrale del Latte di Torino S.p.A.**, in favour of San Paolo IMI S.p.A. as surety for medium-term loans of 3,295 million lire, fully repaid on September 30 2000, and 600 million lire that will fall due on April 1 2001.
